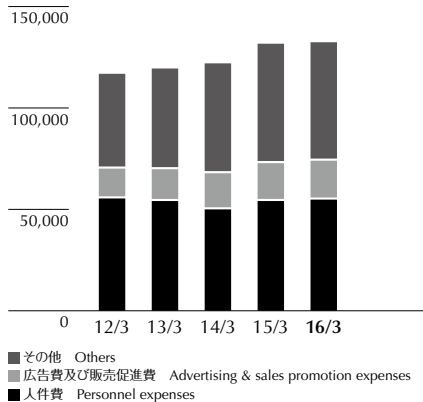

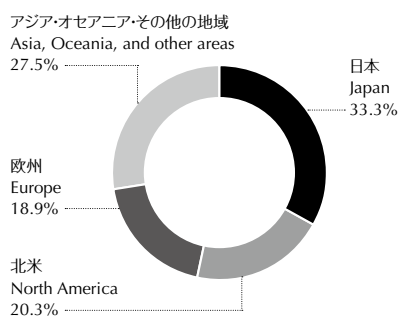

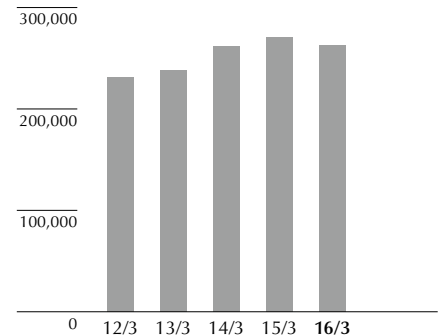
地域別売上高 (2016年3月期) Sales by Region (Year ended March 31, 2016)

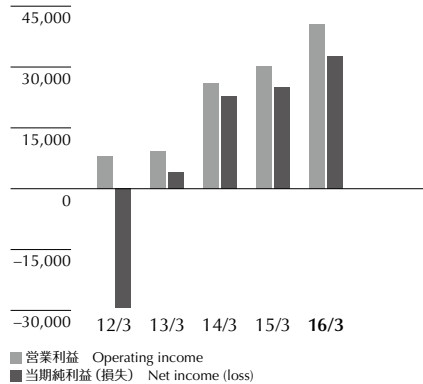
売上原価 Cost of Sales

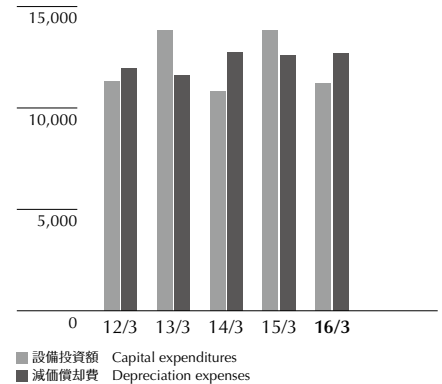

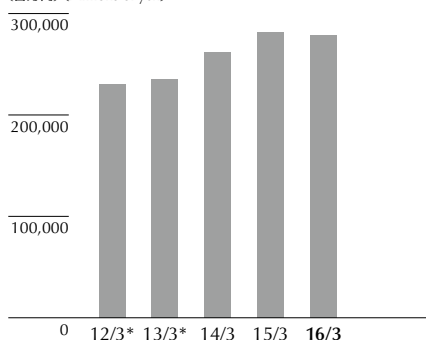

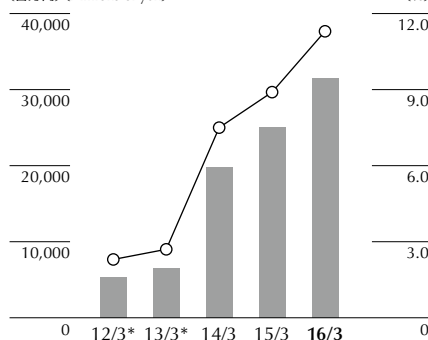

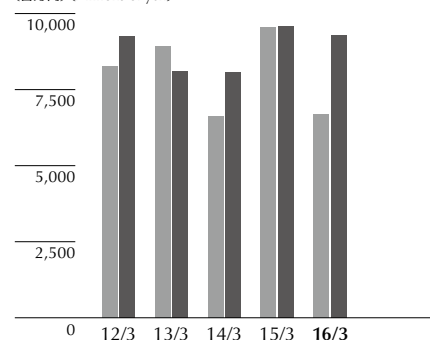

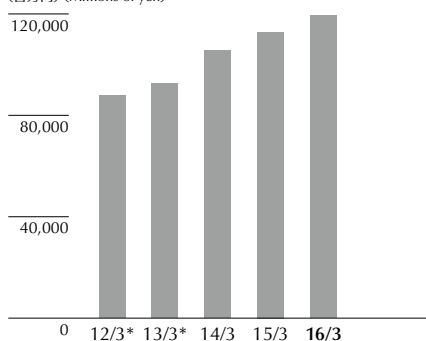

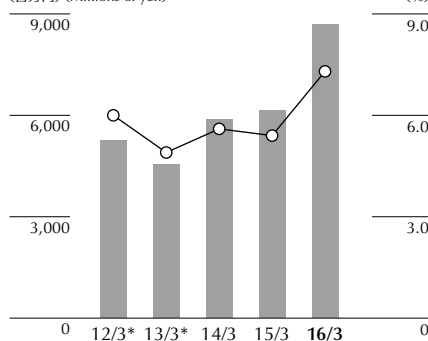

営業利益/売上高営業利益率 Operating Income/ Operating Income to Sales

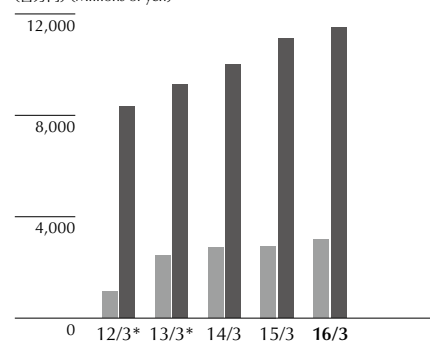

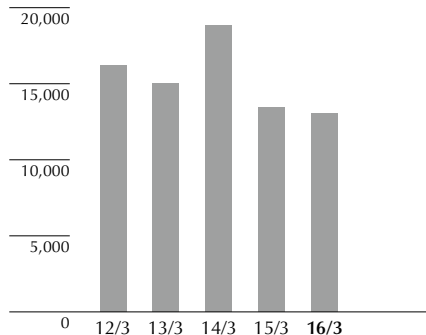

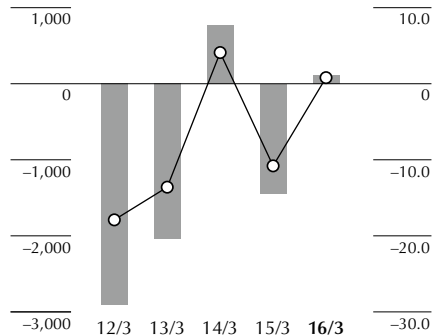

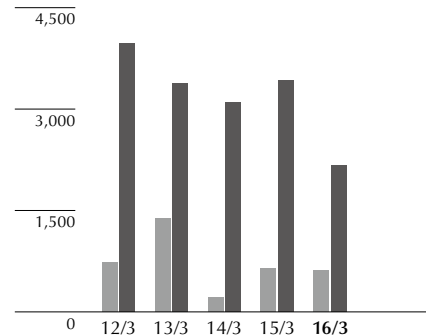

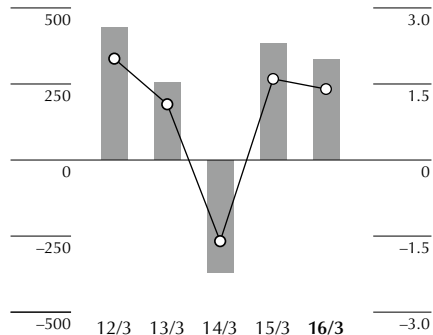

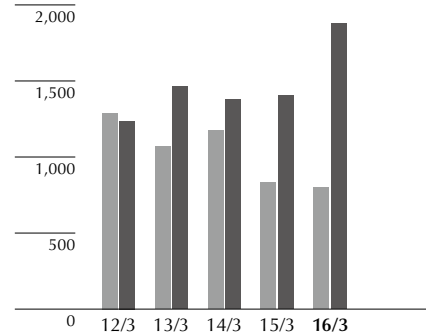

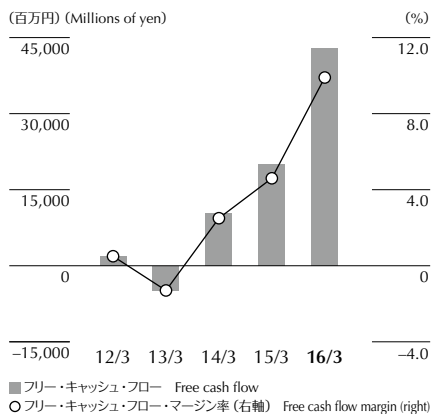

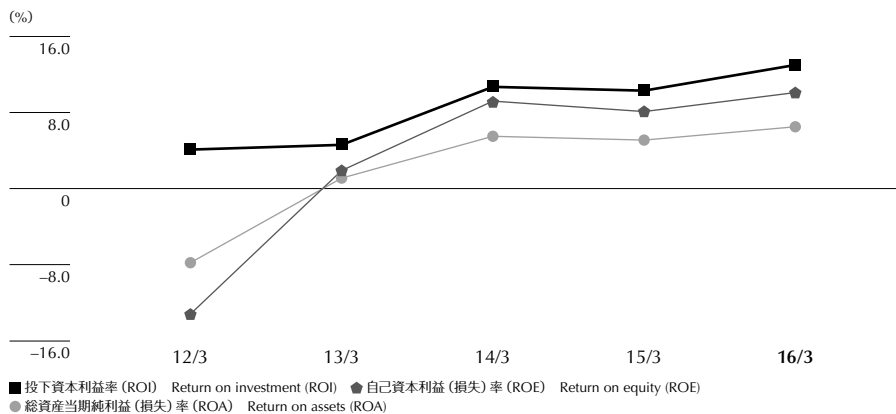

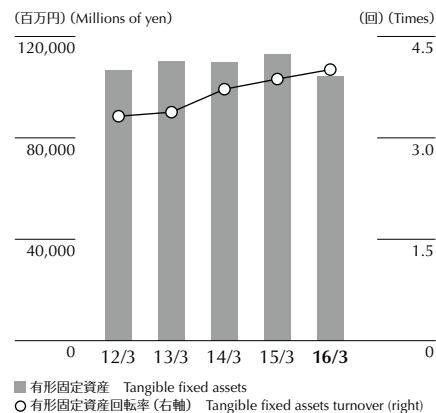

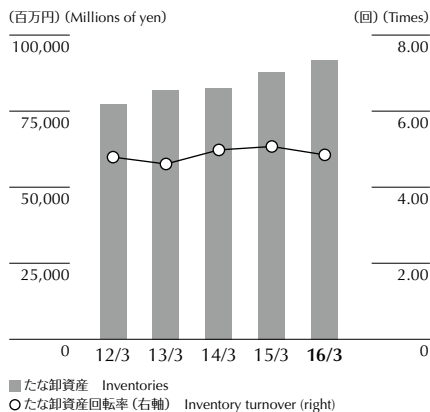

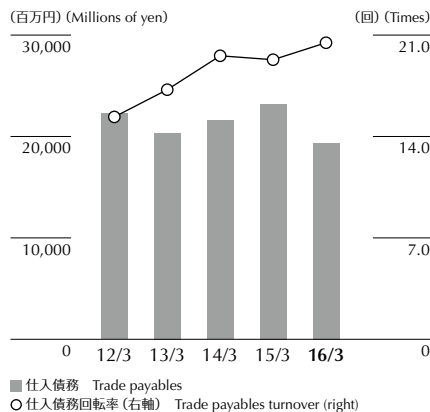

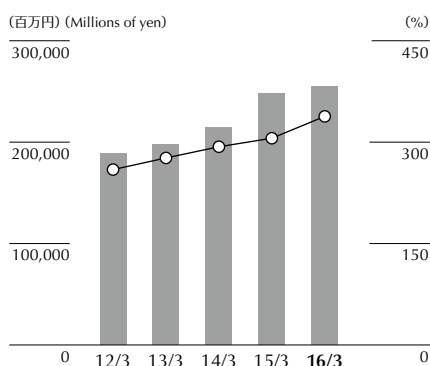

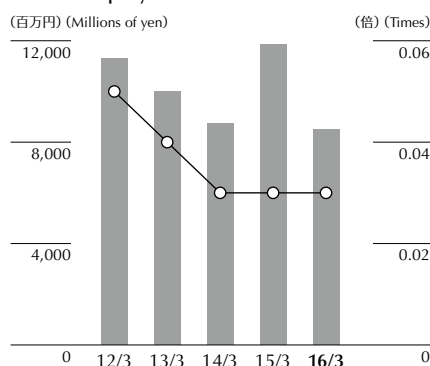

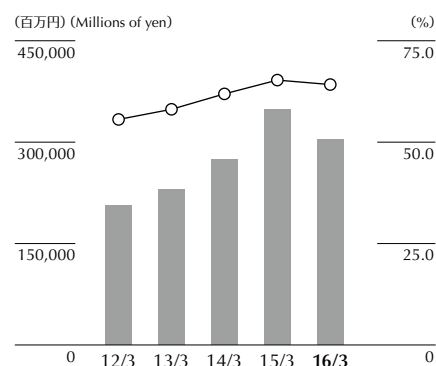
Interest-Bearing Liabilities/ Debt to Equity Ratio

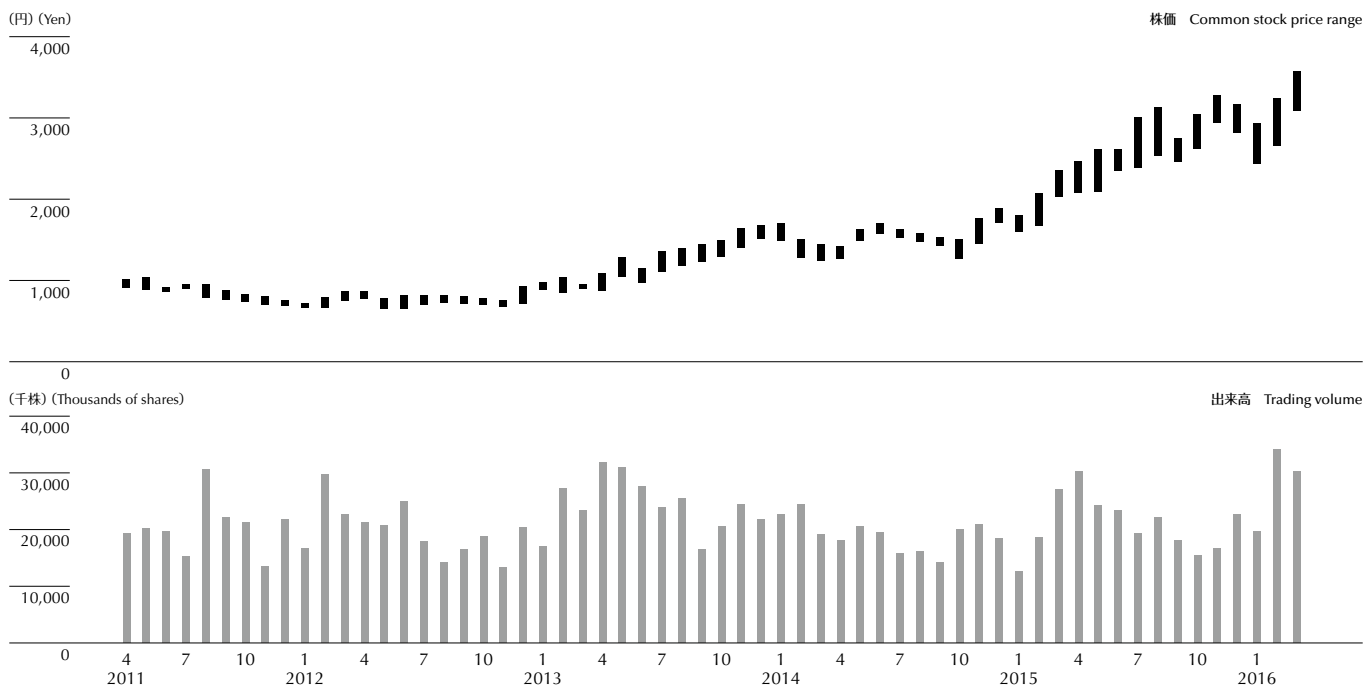

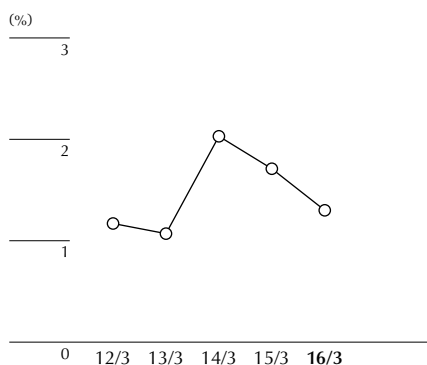
Common Stock Price Range and Trading Volume



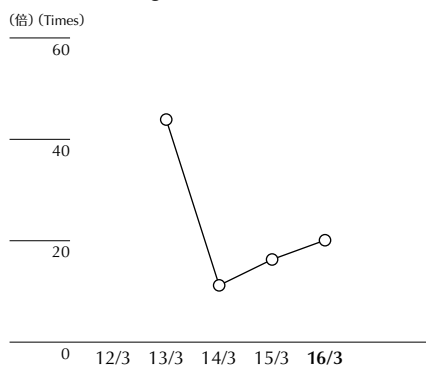

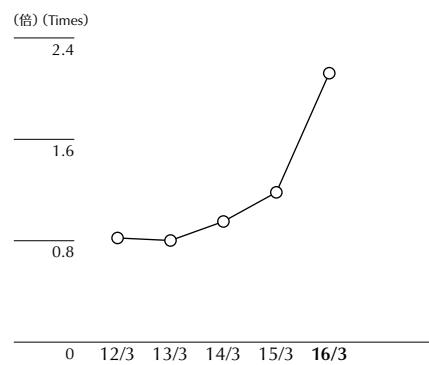
配当利回り Dividend Yield

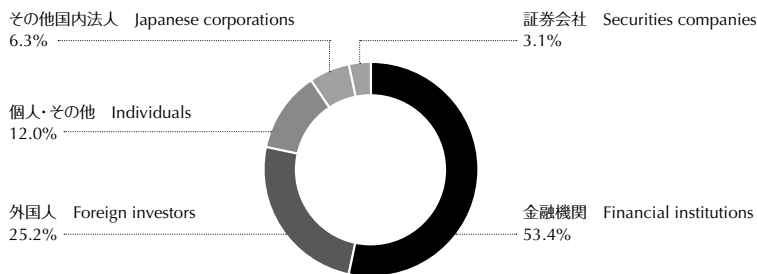
